Areas of Cooperation:



3. To provide all the required infrastructure and venue for organizing any kind of academic event.



Scope of Cooperation:

1. The scope of cooperation includes any academic programme offered by either institution subject to mutual consent.
2. This MoU shall remain in force for a period of five years from the date it is signed by the appropriate officials of both the institutions.
3. It may further be extended or amended with the written agreement of both parties.
4. This MoU may be terminated by either party subject to the delivery of two months advance notice in writing.
5. Both parties understand that all the financial arrangements will have to be negotiated and will depend on the availability of funds.
