MEMORANDUM OF UNDERSTANDING (MoU)

This Memorandum of Understanding (MoU) is made and entered into on this 5th September, 2022 by and between:

1. VSSD College, Nawabganj, Kanpur, an esteemed institution dedicated to higher education, located at Nawabganj, Kanpur, Uttar Pradesh, hereinafter referred to as "VSSD College".
2. Yati Sankalp Sansthan, a social organization committed to community welfare, social service, and ethical initiatives, hereinafter referred to as "Yati Sankalp Sansthan".

Both parties, hereinafter referred to collectively as "the Parties", acknowledge their mutual interest in fostering social service projects and community engagement activities for students.

1. Objectives of the MoU

The objective of this MoU is to facilitate collaboration between VSSD College and Yati Sankalp Sansthan in implementing social service projects where students of the college actively participate in community welfare initiatives.

The key focus areas include but are not limited to:

- Conducting awareness programs, health camps, environmental drives, and social outreach initiatives.
- Encouraging student involvement in real-world social service projects.
- Utilizing VSSD College campus for training sessions, discussions, and relevant programs.
- Providing students with hands-on experience in community service and leadership development.

2. Roles and Responsibilities

VSSD College, Kanpur shall:

- Facilitate the participation of students in the social service projects initiated by Yati Sankalp Sansthan.
- Allow the use of college premises for training, workshops, and other project-related activities, subject to prior approval and availability.
- Designate a faculty coordinator to liaise with Yati Sankalp Sansthan and oversee student participation.
- Ensure that students are made aware of the projects and encouraged to contribute actively.

Yati Sankalp Sansthan shall:

- Provide volunteering and social service opportunities to students.
- Organize training sessions, workshops, and field activities to develop students' social responsibility.
- Cover the financial expenses related to the execution of these projects.
- Offer certificates of participation and recognition to students for their contributions.
- Ensure that all activities comply with ethical and legal standards.

3. Financial Arrangements

- Financial assistance shall provided for various joined programmes by both parties under mutual consent at all points.

4. Duration & Renewal

This MoU shall remain in force for a period of three (3) years from the date of signing.

It may be renewed, modified, or terminated upon mutual agreement between both parties with prior written notice.

5. General Terms

- Both parties agree to work in good faith and ensure smooth execution of projects.
- Any dispute arising out of this MoU shall be resolved through mutual discussion.
- This MoU does not create any legal or financial obligation beyond the terms specified herein.
