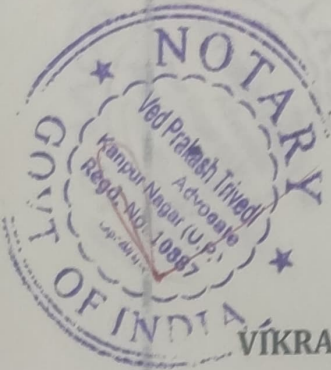

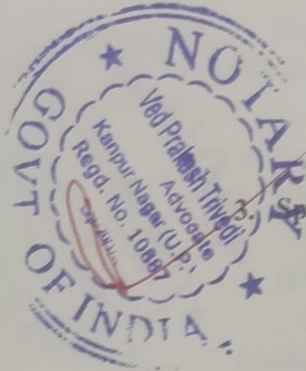

1. **Scope: The initially proposed activities within the scope of the current MoU are:**
The KNN and V.S.S.D. College support each other in promoting various schemes related to public health, environmental issues, and awareness generation activities, trainings, maternal health etc, Activities both long- term and short-term on various issues related with well –being of the society and commonly found in objectives of both the organizations, documentation of various programs and activities. ✓

2. **Coordination between KNN and V.S.S.D. College:**

- A. The V.S.S.D. College will assist KNN in imparting skills/ training needed in professional social work to the workers of KNN in various sectors as and when needed or planned with the consent of both the organizations.
- B. The KNN will support V.S.S.D. College in its extension activities (out of V.S.S.D. College campus) and facilitate the practical exposure if field distance is far and training related to the exclusive activity to the students from time to time. ✓
- C. The KNN would permit PG and/ or Ph.D. students from the concerned departments of V.S.S.D. College for any kind of research on KNN projects such as Social Work or Lifelong Learning etc. for short or long term (depends on time duration of training i.e., it can be of 2 hours or 2-3 days) training in related areas. ✓



Special Provision :

- A. The number and branch of students for such training/dissertation may vary from year to year and would mutually be worked out between the two organizations.
- B. The students working at V.S.S.D. College will be allowed to avail the pilot scale facilities (such as conference hall, chairs, system and other facilities as per requirement) available at KNN and the Organization will extend all necessary support to the research students.
- C. There will be no any financial liability on the V.S.S.D. College.

4. **Duration, Termination & Amendment:**

- A. This MoU shall be valid for a period of 1 year from the date of signing. The duration may be extended with the consent of both the parties under mutually agreed term and conditions.
- B. The V.S.S.D. College and KNN may apply for collaborative projects of mutual interest to external funding agencies. ✓
- C. Data generated through collaborative venture will be published/ patented by both the Organizations. The Intellectual Property Right shall be jointly shared by V.S.S.D. College, Kanpur and KNN. ✓
- D. It is further agreed that the Director, Self-Finance Courses with the permission of the Principal and Management of the VSSD College and the Additional Municipal Commissioner First, Kanpur Nagar Nigam; through periodic meetings will monitor the progress of this MoU. Any change/modification
