- e. Provide research guidance and extend facilities to conduct research leading to research degrees.

3. Implementation of the Memorandum of Understanding

The objectives of the MOU will be implemented and regulated in the following manner.


Students exchange

4. Duration and Residence of MOU-

- c. This MOU is being signed purely with the intention of academic and cultural cooperation.




