## MEMORANDUM OF UNDERSTANDING

This MoU is entered into on this **-02-08-2025**

By and between:

- Jagran Institute of Management and Mass Communication (JIMMC), located at 620, Barra Bypass Rd, W Block, Juhi Kalan, Saket Nagar, Kanpur, Uttar Pradesh 208014 hereinafter referred to as **First Party**,

AND

- Department of Law, VSSD PG College, Nawabganj, Kanpur 208002, affiliated to CSJM University, Kanpur, hereinafter referred to as **Second Party**.

### **Article 1: Purpose**

The purpose of this MoU is to establish collaboration between JIMMC and the Department of Law, VSSD PG College for offering a Certificate Course in Legal Journalism to equip students with interdisciplinary skills combining legal knowledge and journalistic practices.

### **Article 2: Course Details**

**Title of the Course: Certificate Course in Legal Journalism**

**Duration: Three Months**

**Mode: Hybrid Mode classes at VSSD PG College, Nawabganj, Kanpur**

**Eligibility: Open to students of VSSD College and students of JIMMC and other interested candidates**

**Certification: Joint certificate to be issued by both institutions upon successful completion**

### **Article 3: Financial Aspects**

- A minimum registration fee of ₹2,000 will be charged from students of VSSD PG College and JIMMC for the aforementioned 3-month course. The minimum number of students required to commence the course is 150, and a maximum of 250 students will be accommodated in the first batch.
- A separate course fee of ₹3,500 will be applicable for external candidates registering for the course.
- Expenses related to guest lectures, honorarium, printing, and logistics will be jointly managed or handled as per mutually agreed terms on a per-batch basis.
- After deducting the expenses, the remaining fee amount will be equally shared (50-50%) between the Law Department of VSSD College and JIMMC for the purpose of advancing academic and institutional development activities at their respective institutions.

### **Article 4: Roles and Responsibilities**

#### **Jagran Institute of Management and Mass Communication (First Party)**

- Provide media and journalism experts for teaching and mentorship.
- Assist in course promotion and documentation.
- Design modules related to reporting, media ethics, and legal writing.

#### **Department of Law, VSSD PG College (Second Party)**

- Provide legal experts for course delivery.
- Manage student registrations and in-campus logistics.
- Offer academic and administrative coordination for the course.

### **Article 5: Advisory Committee**

- An Advisory Committee shall be formed comprising representatives from both institutions to:
- Oversee curriculum design and updates
- Monitor quality and relevance of the course
- Review performance and suggest improvements

### **Article 6: Term and Termination**

- This MoU shall remain valid for three (3) years from the date of signing and may be renewed through mutual consent.
- Either party may terminate the MoU by giving three months' prior written notice.
- Incomplete sessions shall be allowed to continue until the current batch completes.

### Article 7: Amendments

Any amendment or modification to this MoU shall be made in writing and signed by both parties. IN WITNESS WHEREOF, the parties have executed this MoU in two originals and agree to abide by the terms set forth.


